Out Newton corner – ERYC have been carrying out some work there but still standing water is present – Flood signs are in place.

Back Street verges have been reported to ERYC, Mike Peek visited last Friday and also looked at the highway at Kilnsea opposite C&A – no report as yet received.

Request for bollards along the grassed area opposite C&A will be carried out in the new financial year by ERYC. Cllr Martin offered items left at the Boat Yard if required.

Clough at Easington has been cleaned and it has also been reported to the EA that maintenance is required.

Proposal: Hybrid application consisting of: (a) Full planning permission for siting 97 static holiday caravan pitches and associated operational development including roads and lakes; (b) Full Planning Permission for the phased clearance of the existing Sandy Beaches holiday caravan site including demolition and removal of all above ground infrastructure and restoration of site as open space; and (c) Outline planning permission for the erection of a clubroom building with associated infrastructure

Hand rails for church steps – Cllr Longhorn had received a request to have rails installed

Eon community grant applications – the next round of funding will be available shortly so residents / interested parties need to consider suitable schemes for which funds can be applied for.

Transport Champion – Clerks update and request for finance of £200 to access a community information bus to be sited in the village square to obtain the community's views on transport links in the area. This was denied but to wait for further information regarding the electric bus first.
